## **Strategy**

### **1. Exchange of data, information and knowledge**

Provide archaeological heritage management agencies with a forum for discussion and exchange of information.

- Yearly symposium, occasional seminar on actual management-issues
- Board-meetings (open to others): exchange of practice and experiences
- Working groups
- Publications
- Website
- Newsletter
- Initiate a community for exchange of experiences (network)

Help to realize a digital infra-structure to exchange archaeological data, information and knowledge.

### **2. Setting of standards**

Identify and develop agreed standards in specific and relevant fields of archaeological heritage management according to need, particularly relating to issues of quality and quality management and other related practical issues of general concern.

### **3. Help making (inter)national heritage-policies:**

Give advice to the Council of Europe, the European Union and national governments on all issues relevant to the management of the archaeological heritage in Europe.

- Monitoring-activities
- Links scientific research with heritage-management issues

EAC does not engage in political activities and does not make public statements on the decisions or possible decisions of (inter)governmental bodies.

EAC will achieve these goals by:

- *Seeking to connect and cooperate with relevant international heritage organisations like the European Heads of Heritage Forum*
- *improve support/awareness/consideration/appreciation of the value/importance of archaeological heritage*
- *Advance and enable pan-European research programmes, management strategies*
